The President's Podium

Legends of the wrestling world. The question is, how do you become a legend? First, you need to decide what is your definition of a legend? The dictionary states "extremely famous in a particular field or well known".

I never wrestled. I graduated from Stranahan High School in 1963 before wrestling existed in our school system. I got involved with the boosters club in 1988 when my son wrestled. In my 34 years of involvement in the sport of wrestling, my wife and I served the wrestling community in many areas. As an outsider, I had a different outlook on the sport and the people involved. I personally feel there are many different categories of a legend in our sport.

First there is the athlete who has had a phenomenal high school or college career, or even made the Olympics.

Then there are coaches that have created early development clubs. They work 365 days a year both mentally and physically, they work in promoting their kid, producing the best athletes and teams in the state year after year.

I have seen many officials work as many as 14-16 hours on the mat officiating tournaments, spending their own money for travel and housing to work tournaments. Many travel out of state and internationally working tournaments.

Contributors are volunteers who have dedicated their lives to support the sport of wrestling.

These are what most people think of as legends. They have made their mark in history and into the record books.

I have also seen in my experience a different type of legend, the unsung heroes in our sport. They may not have the best winning record or produce the most state champions. These are the coaches, officials, and volunteers who work on developing athletes and developing their life skills. They take in troubled kids, promote academics, and work on getting their wrestlers in to college and helping secure scholarships. I have watched officials stop a match in a tournament to show young inexperienced wrestlers wrestling moves and do a short clinic on the rules. I've witnessed officials donate their time doing tournaments for fund raisers. Then there is the volunteer who works tournaments, transports kid week after week to events, and commit themselves year after year.

Most of these individuals do not have the exposure as some of the greats, but they have a commitment to making these young men and women have a better chance to survive in life; and to me, these individuals are also legends in this sport.

Remember, when we do it, we do it with class, for we are honoring the best of the best.

If you are a former wrestler, family of a wrestler, a friend of a wrestler, or part of the wrestling community, come join the celebration!

Beginning Friday evening, August 26, at 8:00 PM, people will gather for a **Meet the Inductees Social**. This social time turns into a reunion of family and friends, or a reuniting of former wrestlers and coaches. John Vaughan Award 2022

This year the John Vaughan Award will be presented to Miriam Jenkins. When she joined the Gainesville High School wrestling team in 1996, the women's wrestling movement was very limited in its growth. Miriam managed to start the 1998 season on the varsity team and compiled a record of 28-12 against all male competitors and qualifying for the Regional Tournament.

The following year she compiled a record of 32-11 and became the first female wrestler in Florida to win a District Tournament. She made Florida history the next weekend when, at the Regional Tournament hosted by NB Forest High School in Jacksonville, she placed 3rd, becoming the first female wrestler in Florida history to quality for the State Tournament. The following weekend Miriam made national history when she defeated her firstround opponent, a wrestler from Okeechobee High School, by a score of 7-5, becoming the first female wrestler in the nation to win a match at a Male State Tournament.

JOHN VAUGHAN

September 25, 1914 - April 29, 2006

He changed the face of wrestling, and with that bold stroke John Vaughan gave the United States a chance to compete on even terms with the rest of the world. From his days of collegiate competition through the course of a spectacular business career, he has been one of the sport's most intense boosters, with an unbridled enthusiasm for wrestling.

John's biggest impact on the sport came in 1988, when he began underwriting cash awards for USA wrestlers winning medals in the Olympic Games, World Championships and other major events. With additional support from the Team USA program, the nation's top wrestlers now are able to remain active for many "extra" years. Many of their talented predecessors were forced into early retirement for purely economic reasons.

Vaughan has been a quiet supporter of programs at Indiana, Ohio State, Ohio U, Case Western Reserve, Michigan, Oklahoma State, the U. S. Association for Blind Athletes, and particularly USA Wrestling. He and his wife Helen are national sponsors of Greco-Roman Team USA.

He established the endowment fund of the National Wrestling Hall of Fame, and has served as president and chairman of the Hall of Fame, as a director of USA Wrestling, and as a member of the marketing commission of the International Wrestling Federation (FILA).

Vaughan enjoyed three outstanding seasons in the mid-1930s at Case Tech. He was undefeated as a junior and senior, and continued to compete for a YMCA team in Cleveland until World War II.

He obtained his degree in electrical engineering and launched his business career by earning 10 U. S. patents in electric control systems and induction melting furnaces. He purchased his first company, an equipment manufacturer for restaurant kitchens, in 1952, and created the diversified Alco Standard Corporation in 1965.

In recognition of his enthusiastic support of wrestling, and the courage to turn the sport in a new direction, John Thomas Vaughan is honored as a Distinguished Member of the National Wrestling Hall of Fame.

Outstanding American Award

Outstanding American

Given to former wrestlers who are highly successful and use the disciplines learned in wrestling in their profession.

In the twenty-plus years of the Florida Chapter, only seven Floridians have ever received this award: John Vaughan (2000), Monsignor Michael Devine (2001), Captain Stephen Archer (2002), Frank Brogan (2002), Dominic Gorie (2012), Gerald Brisco (2018) and this year, Kevin Pedersen. Here is part of Kevin's nomination letter: "Former Special Agent Kevin Pedersen took all the lessons he learned from wrestling – Initiative, Determination, Teamwork, Discipline, Devotion, Aggressiveness, 'A Will to Win', Integrity, Honor, Goal-Setting, and Leadership - and applied them to his service as a U.S. Army officer for six years and then a DEA Special Agent for 21 years." The Florida Chapter is honored to be adding Kevin Pedersen, Class of 2022, to the National Wrestling Hall of Fame.



QUALIFIED CHARITABLE CONTRIBUTIONS FROM IRAS

RETIREMENT PLANS

Certain IRA holders have the opportunity to make tax-free distributions from their IRAs to qualified charitable organizations. For tax-free eligibility, the qualified charitable distribution (QCD) must be sent directly from the IRA payable to the receiving qualified 501(c)(3) non-profit organization.

Eligibility and Donation Limit

IRA holders must be at least 70½ years of age before the distribution. In addition, beneficiaries of inherited IRAs who meet the age requirement can also take advantage of QCDs.

For those who qualify, the maximum IRA charitable distribution is limited to \$100,000 per tax year. Any distribution in excess of this limit will not qualify for the tax exclusion benefit and will be treated as ordinary income. The provision applies for Traditional, Roth, and inherited IRAs, but does not typically apply to distributions from "active" SEP or SIMPLE IRAs.

Benefits of a QCD

If a taxpayer makes the donation as prescribed by the IRS, then the distribution will be excluded from gross income and counts toward:

- The taxpayer's \$100,000 exclusion limitation for the year the distribution occurs and
- The taxpayer's required minimum distribution (RMD) for the current year

With the increase in the standard deduction for 2018 and future tax years to \$26,600 for married filing jointly age 65 or older and \$13,600 for single filers age 65 or older, more Americans will be using the standard deduction rather than itemizing deductions on their tax returns. QCDs are excluded from taxable income, but do not allow for an itemized deduction. If more individuals age 72 or older use the standard deduction, the QCD is a great way to keep taxable income lower when satisfying an RMD and still get the full benefit of the standard deduction. By using the standard deduction, a taxpayer will receive no benefit for their charitable contribution unless it is processed as a QCD from an IRA. In addition, by not including a charitable donation from an IRA as ordinary income, an individual's adjusted gross income is not increased, which could affect the ability to:

- Qualify for Roth IRA contributions
- Avoid other potential tax ramifications, such as:
 - 1. The 3.8% health care surcharge. (Even though distributions from IRAs are exempt from the 3.8% health care surcharge, taxable distributions from IRAs could push income over the threshold amount, causing other investment income to be subject to the surtax.)
 - 2. Paying more for Medicare Premiums.
 - 3. Taxation on Social Security Benefits.

QCD Tax Reporting

Typically, the custodian of an IRA will report a QCD as a normal distribution on the 1099R tax form, while QCDs from inherited IRAs are reported as death distributions. This gives the IRS no notification that an IRA holder intended to make a tax-free distribution from the IRA to a charity. It is the responsibility of the IRA holder or his or her tax preparer to properly report the QCD on a 1040 tax return. It is also strongly suggested that the IRA holder obtains a receipt from the charitable organization.

Memories of Great Matches Involving Florida Wrestlers by Ira Fleckman, Class of 2006, Contributing Writer

LOUIS ARCHER, Miami Beach HS

Louis Archer was a solid wrestler from Miami Beach HS. He had a younger brother Jeff, but more about him later. Louis was a member of our 1987 National Team. He wrestled in the 165 classes where his record was 1-2 in Greco-Roman and 0-2 in freestyle. Yet, Louis was an important part of that great team.

Somewhere during the tournament, Louis became our cheerleader. He somehow organized the other guys and fired them all up. I can't say who had the idea for the Team Florida TOGA PARTY from bed sheets, or who designed the big AIR FLORIDA banner, but I know that Louis was the one waving that banner and in the middle of the loudest cheers from the Florida wrestlers.

The 1987 National Team finished 4th in Greco-Roman and 9th in Freestyle. There were three finalists in Greco-Roman and one in Freestyle. There were six Greco-Roman All Americans and three Freestyle All Americans. The Florida team members cheered every one of them.

The National Juniors is a marathon of a tournament and each wrestler finds it harder to get up for the next match as the days go by. Teammates find it tough to lose their own matches and still find the energy and spirit to cheer those still wrestling. Louis Archer was the core of the support for his fellow team members.

Louis had his share of excitement, too. It seems that Louis had a bout with a California wrestler; at least I believe he was from California, who did something Louis didn't much care for. Louis decked the youngster. The referees disqualified Louis. This act of unsportsmanlike behavior didn't sit too well with the coaching staff, but Louis felt justified. After an investigation of the incident, it was determined that Louis acted improperly but was provoked. That allowed Louis to stay.

Waving a banner and wearing bed sheets don't mean a thing if the wrestlers don't perform, but on the other hand, this team was inspired. Louis Archer was one that helped to inspire his teammates.

Louis's brother Jeff was a larger guy. Much more laid back than Louis and he wrestled about 191.5. He borrowed one of my kneepads at a different tournament some years later and I am still looking to get it back.

I would never say that a wrestler should pay for a trip to nationals, go through a tough camp and work and drill in order to be a cheerleader. However, when one has exhausted himself in his efforts to place, when one has been eliminated after giving it

his very best shot, it is a worthy sacrifice to do whatever one can to provide support for one's team mates. The unselfish act of Louis Archer and the rest of that team of 1987 was a big part of the reason that Florida had the great showing it did.
