Bob Hartley Class of 2010



Bob has three sons, Brett, Brian, and Robby, from his first marriage, and Dak, his stepson. Brian was a three-time State placer. Bob lost Dak's mom, JoAnn, after 29 years of marriage, and recently has been lucky enough to find a new love. Bob and Cindy were married in June of this year.

Bob attended Auburndale High School and graduated in 1972. During his senior year he joined Auburndale's first wrestling team, one of the first six teams in Polk County. This is where his love of wrestling began. He would then attend Polk Junior College in Winter Haven and got his first taste of coaching while assisting at his old high school. He would then attend Florida State in Tallahassee and wrestled in their intermural program. While there, he helped Godby High School begin its first wrestling team.


Bob then entered the teaching profession where he remained active with wrestling programs. He would eventually work his way up to become an Assistant Principal, work out of the County Administration Office, become the Principal at Lake Highland, and then Stanbaugh Middle School, and finally would work at Southeastern University as a professor. He also helped that school begin it first wrestling program. He left the teaching profession the take care of his wife when she became ill.

Besides his coaching, Bob became an official in 1973 and would serve for 51 years before retiring in 2024.

As for Bob's hobbies, he like to play golf and pickleball as often as possible during the week. During the wrestling season he still enjoys going to watch matches at the local high school.

Today he will tell you that "wrestling has been very good to him." We can say "Thanks Bob, for helping the sport of wrestling grow in Florida."

WRESTLING HISTORY



Wayne Wells



He stood atop the Olympic awards stand, gold medal draped across his chest, and sang the Star-Spangled Banner. In the proudest moment of his wrestling career, Wayne Wells thanked his country for the opportunity to excel.

Given that opportunity, he spent a dozen years of hard work, building upon the cornerstones of skill, conditioning and desire. Among many rewards, were a few setbacks, but each was a spur to higher achievement.

At the University of Oklahoma, Wayne was a three-time Big Eight champion and a two-time All-American. NCAA runner-up as a junior, he won the championship the following year and went on to earn fourth place in the Olympic Games of 1968. While turning his attention to law school and the foundation of his professional career, Wayne intensified his wrestling efforts. He captured the silver medal in the 1969 World Championships, then returned a year later to win the gold.

He won two national freestyle titles and placed second in the Pan American Games. In the months leading up to the 1972 Olympics he completed his final year of law school, passed the state bar exam, assisted the OU coaching staff and trained five hours a day.

As evidence of his preparation for the Olympic effort, his scores in the strength-endurance tests exceeded those of all other members of the United States wrestling team. And in a final victory over adversity, he dominated his opposition despite a separated and displaced rib, an enlarged spleen and a badly damaged knee.

Throughout his athletic career, and then as a respected member of the legal profession, Wells was a positive force for every organization or team with which he was involved.



Greetings, fellow officials.

Ten Tips for the New Season

- 1. Review the NFHS Rules Book and the Case Book. Many problems can be solved by reviewing the situations provided in the Case Book. Also review the illustrations in the Rules Book.
- 2. Review and practice all approved signals in front of a mirror. Use only these signals during a match.
- 3. Watch other officials and review videos of matches. Don't be afraid to have other officials critique your performance on the mat. We can help each other improve our skills.
- 4. Work preseason tournaments and possibly some local school wrestle-offs.
- 5. If you are new, don't be afraid to work sub-varsity matches to develop your skills.
- 6. When making close calls, don't look to the coaches for approval. This only opens the door for coaches to question any call.
- 7. If you make a wrong "correctable" call, it is okay to wipe it off. Remember it is our job to be fair to both wrestlers. Coaches will respect you for your fairness.
- 8. If you "miss" a call that you cannot fix, do not become defensive with the coach. There is no shame in admitting to a mistake. Coaches will respect your honesty.
- 9. Be consistent with your calls from one match to the next. Consistency is important on all calls whether it is for stalling, takedowns, line calls, nearfalls, etc.
- 10. Practice the three "BFs"- Be Friendly, Be Fair, and Be Firm.

(Editor's note: Yes, the season has started, but these are still valuable tips!)

Memories of Great Matches Involving Florida Wrestlers

TROY TURNER: As hard-nosed a wrestler as ever competed in Florida.

Troy wrestled for Seminole HS in Sanford. He made it to the State Finals three years in a row. Troy was powerful but didn't have a great deal of technical skill. He certainly knew how to wrestle and he was tough as any wrestler who ever laced up his boots here in Florida.

In 1985, Troy made it to the finals and had to face Mark Surette of Seminole HS in St. Petersburg. That has to be confusing in the record books, both wrestlers from Seminole HS. Surette pounded Troy without let up and won 19-8. Troy never quit but kept battling the entire match. That was at 155.

The following year, 1986, also at 155, Troy broke his thumb in the first period of the match in the semi-finals. He continued to wrestle and won the bout. After going to the hospital, the doctor refused him permission to wrestle and he had to default in the finals to a wrestler he had beaten in a dual meet during the year.

However, the third time was the charm, as they say, in 1987 at 167 Troy defeated Dennis Nelson of Countryside to win his state championship 9-1. Troy was a respectful young man who had dreams of racing cars in the professional racecar world. His younger brother Tracey wrestled, too and was pretty good himself. Troy stuck it out and won and with that attitude, ¹⁹ if he races cars, he will probably win in that venue, too.

The mission of the Florida Chapter of the National Wrestling Hall of Fame is to pay tribute to those coaches, officials, and contributors who represent the best qualities of what the sport of wrestling has to offer and who share those characteristics with young people day in and day out.
